Letter of Appointment – Managed Accounts Services

The above Account Holder authorizes the above Appointed Trader to have full access to his trading account at Alpari. Such access includes making discretionary decisions to use the Account Holder’s login ID and Passwords to access his account to trade the funds available in his account.

The Account Trader appoints the above Account Manager to provide Managed Accounts Services for him, including account trading transactions and clients services.

The above Account Trader hereby agrees to offer professional accounts management services for the Account Holder. By managing the account, the Account Trader shall make best possible trading orders executions in order to generate profitable trades. However, the Account Trader does not at anytime offer any guarantee of profits to the Account Holder. The Account Holder also agrees that the Account Trader will not be held liable for any losses that might occur in his account.

The Account Holder, by signing this letter of appointment, understands that spot gold trading involves substantial risks, and the account could suffer substantial losses. The Account Holder also agrees that, he cannot hold the Account Trader (Goldtrades Info Company Limited, registered in the British Virgin Islands) or any of its employees or affiliates liable against any financial losses that he may suffer from the trading transactions in his account.

The Account Holder, by signing this letter of appointment, also agrees to pay the following fees to the Account Trader: Monthly performance fee is deducted from total monthly profits from the account)

[A] VIP Managed Accounts Services (Min USD25,000) Fees:

15% if monthly profits is above 3.01%

[B] Platinum Managed Accounts Services (Min USD10,000)

0% if monthly profits is below 3%
16% if monthly profits is above 3.01%

[C] Gold Managed Accounts Services (Min USD3,000) Fees:

0% if monthly profits is below 3%
18% if monthly profits is above 3.01%
